## Showing our Less Photogenic Side: Red Light Cameras in Florida

Jacksonville has been a 'Southern City' for a long time not only geographically but culturally. Yet, we have been influenced over many years by the transit of military members and influx of new residents from elsewhere because of our robust port and hardy business climate. These changes have created a unique and dynamic population. As a result, one element of our nature that has become even more dynamic is our driving. When roads are open, we vigorously engage to get to where we are going speeding past Palm trees and moss covered oaks. At times, our vigorous nature is expressed at intersections and result in accidents. To reign in that more modern nature in all Floridians, the legislature enacted a new statute called the Mark Wandall Traffic Safety Act (FLA. STAT. 316.0076 (2012). It is named after Mark Wandall who was killed as a result of another driver running a red light. 1 The statute provides the State of Florida with the overarching regulatory power to use red light cameras for traffic enforcement, 2 Some Florida cities and counties had previously implemented camera enforcement through local ordinances. 3 However, Florida officially began allowing statewide use of cameras in February of this year. 4 By the end of May this year, there were a total of 9900 violations recorded by 18 cameras in Jacksonville alone amounting to fines of \$477,000. 5 The red-light camera recording the most violations is at the intersection of Atlantic Boulevard and Monument Road. 6 The goal of the statute is to make intersections safer. However at present, research provides conflicting results. Some studies have shown a decrease in side impact crashes. 7 Other studies have shown increases in rear end collisions from cars braking hard to avoid a ticket. 8 The hope is for fewer accidents and fatalities. Future studies will hold the answers. When a violation is captured on camera, a violation notice is sent by regular mail to the owner of the car. 9 The fine starts at \$158 if paid within the 30 day grace period. 10 If not paid in that time, the citation becomes a traffic citation for \$274 and can be contested in court. 11 If the owner of the car can establish one of four scenarios, he may be released from liability under the law. 12 First, the owner of the vehicle can establish that he was passing through the red light to allow an emergency vehicle to pass or was part of a funeral procession. 13 Second, he could establish that he went through the light at the direction of law enforcement. Third, the owner can establish that the car was in the custody and control of another person at the time of the infraction. 14 This exemption seems like the easiest one to declare. However, proof must be provided. Lastly, he could establish that a citation was already issued to the driver for this incident by law enforcement.15 One way to avoid having to come up with one of the four reasons is to hearken back to those less stressful Southern days and just enjoy the ride.
